Major Activities

- Generic:
 - Department of Commerce has recently come up with a Draft Indian National Strategy for Standardization (INSS).
 - Cabinet approved the introduction of the Consumer Protection Bill, 2017, to amend the Consumer Protection Act, 1986.
- Smart Cities:
 - Government announced names of nine more cities under Smart Cities Mission & Liveability Index
 - India and Germany have inked MoU for "Implementation Agreement in Sustainable Urban Development and Smart Cities in India

Electrical Equipment incl. Consumer Electronics:

- Cyber security standards for power utilities: Two BIS groups to issue norms within 6 months: IS 16335
 update and adoption of IEC 62443 & Guidelines for Certification of Capacitors as per Indian Standards
- Automotive:
 - Govt unveils draft National Auto Policy to promote green mobility on Business Standard.
 - Society of Indian Automobile Manufacturers (SIAM) forecasts 100 percent of new electric vehicle sales by 2047.
 - Automotive Research Association of India (ARAI) is working on building a facility that will test EV batteries which is a key part of e-Mobility.
 - ICT:

- Department of telecommunication is working on releasing guidelines for the introduction of machineto-machine (M2M) communication services in India & expects to finalize 5G service roadmap by June

Generic:

- Union Ministry of Commerce and Industry released <u>draft Indian National Strategy for</u> <u>Standardization</u> of products and services to provide level playing field to domestic industry and adopt best global practices.
- Cabinet has approved <u>Consumer Protection Bill</u>, pending Parliament approval
- BIS working on the part two of Indian Standard 16335 which would consider India Smart Grid Forum (ISGF) cyber security manual as reference document
- Bureau of Indian Standards (BIS) has issued <u>Guidelines for Certification of Capacitors as</u> per IS 2993, IS 13340 (Part 1) and IS 13585 (Part 1)
- <u>The Bureau of Indian Standards (BIS) has published Memorandum of Understanding</u> (MoUs) with National Standards Bodies (NSBs) of 23 countries.

Smart Cities:

- Update on 100 Smart Cities Mission
 - 09 winning cities in Round 4 of the Smart Cities Challenge announced by MoUD
 - Govt launched liveability standards to rate & rank 116 Indian cities
 - Three Indian cities Panaji, Pune and Rajkot selected as national finalists in the 2017-2018 edition of WWF's One Planet City Challenge (OPCC).



Quarterly Report: Snap Shot 2 (4)

Electrical Equipment including Consumer Electronics:

• Government is working on amendments to the Electricity Act to levy hefty penalties on power distribution companies.

Automotive:

- Department of Heavy Industries (DHI) has released <u>draft National Auto policy</u> to provide a long-term, stable and consistent policy regime and roadmap: Standards alignment with global standards are part of it
- Society of Indian Automobile Manufacturers (SIAM) presented a roadmap for the complete shift towards electric vehicle regime by 2047.
- ARAI (Automotive Research Association of India) has set up labs for testing BS-VI engines and is planning to start testing facility for Electric Vehicle (EV) batteries in 6 months
- Government decided to cap the life of commercial vehicles(CVs) to 20 years means any CV reaching the 20 year age limit will be automatically de-registered and can not ply on road from April 1, 2020
