## ❑ **Generic:**

- Indian Government mandates stringent Quality Control Order for Solar Equipment
- Ministry of Electronics and Information Technology (MeitY) released Modified Market Surveillance Process
- Bureau of Indian Standards (BIS) has notified Conformity Assessment Regulations, 2018

## ❑ **Smart Cities:**

- Ministry of Housing and Urban Affairs selected Shillong (Meghalaya) as 100th smart city under smart city mission and with this announcement selection of 100 cities has been completed.
- ABB India signs MoU with IIT Roorkee for Smart Cities mission pilot Project

## ❑ **Electrical Equipment incl. Consumer Electronics:**

- Ministry of Power announced that all electricity meters will become smart prepaid meters in next 3 Years.
- Indian government steps up focus on electronics exports, new policy to outline measure

## ❑ **Automotive:**

- Government proposed to set up charging stations for Electric Vehicles every 3 kilometers.
- Government may soon consider FAME-II scheme with Rs 9,381 cr (1.17 euro billion) outlay
- National Institution for Transforming India (NITI Aayog) submits draft Cabinet note on zero-emission vehicle & ancillary technology.

## Electrical Equipment including Consumer Electronics:

- All electricity meters in India will become smart prepaid meters in the next three years : Ministry of Power
- Indian govt steps up focus on electronics exports, new policy to outline measures
- Ministry of New and Renewable Energy (MNRE) released following clarifications/notifications:
  - Revised notification for implementation of Solar Photovoltaics, Systems, Devices, and Component Goods Order 2017
  - "Quality control order of Solar Photo voltaic Systems, Devices and Components Goods"
  - Clarification on charging infrastructure for Electric Vehicles with reference to the provisions of the Electricity Act, 2003
  - Clarification to Guidelines for Tariff Based Competitive Bidding Process for Procurement of Power from Grid Connected Solar PV Power

## Automotive:

- Charging of batteries of electric vehicles through charging station does not any require licence under the provision of the Electricity Act 2003 : Ministry of Power (MoP)
- Government may soon approve Rs. 9,381 Crore (1.17 euro billion) for FAME-II to boost adoption of energy-efficient vehicles in the country.
- Government postponed the mandatory requirement to have Global Positioning System (GPS) for all public transport service vehicles till April 1, 2019.
- NITI Aayog has submitted a draft Cabinet note on developing a strategy for zero emission vehicles and ancillary technology, in order to promote electric vehicles
